TERMS OF COOPERATION AND RESPONSIBILITIES OF PARTICIPANTS

General

1. The organizer reserves the rights to change the program. Any changes will be posted on the website as soon as possible.
2. Deposits are not refundable except in the case of serious illness or unforeseen reasons. For cancellations up to one month in advance of the event, we will deduct a handling fee of 10 Euros, and return the remainder of the deposit to you. For cancellations later than a month before the event, the deposit is non-returnable and for cancellations later than one month before the event, the entire fee is given back to you. In the case that the replacement for your place will be organized from you, we will refund you the total amount paid. In the case of cancellation of the event, we will as well refunded the full amount.
3. Any minor changes in the event (changing the schedule, location, etc.) does not justify the claim for compensation or reduction in value of the tickets.
4. Personal information provided by the visitor entered in the registration form will not be public but accessible only to the organizer .
5. Each visitor must follow the instructions of the team and the representatives of participating in the project, such as transporters, apartments... and behave appropriately according to the law on the protection of public order and peace.
6. With enforcing the payment a visitor confirms that he agrees with the rules of the organizer.

Attendance at your own risk

1. Participation in physical (dance, yoga...) workshops is at your own risk.
2. The organizer is not liable for direct or indirect, material or immaterial damage that may incur to a visitor through participation in events.
3. The organizer is not responsible for personal items or equipment owned or held by the visitor. Visitors have to look after their belongings.

Security

1. Each visitor should take care to protect their property and health. Before the start of the event every visitor is obliged to provide his health insurance, and to pay tourist tax on arrival at the island.
2. Visitors younger than 18 years old, must submit a permission to join the workshops from their parents or guardians.
3. In the case of violating the laws of Croatian Constitution the visitor may be reported to the competent authorities and removed from the area.
4. The organizer reserves the right to record and shoot the events for the purposes of promotion. If a visitor do not want to be in the photos and videos he can make a preventive request and the prohibition to be filmed and photographed. Once the promo material has been edited the removal will be difficult.
